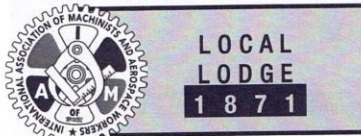
Vice President Peter Baker will fill the president's position until December in which an election will determine the president and officers for the 3 year term.

IF YOU HAVE A CHANGE OF ADDRESS please communicate that to us. The company does not alert us to address changes. Pass the word.

As of right now, it looks like the bonuses will be issued around the end of July or beginning of August. Blue/Gold team payouts for the difference in time are still being worked on.

OSM has a road trip to Virginia coming up. I would like to remind people to be diligent in wearing their masks there. I ask the same for us here in Groton. The mask is to protect others, not yourself. You may not be worried about getting sick but keep in mind that others may already have weakened immune systems or be living with a family member who does. Please be considerate and wear your masks when around others.

One issue I would like to clear up is about how to handle direction that we disagree with from a supervisor. We are supposed to follow all directions given by supervisors. If you have an issue with the direction, document the event and grieve it afterwards. If you feel the direction creates a safety hazard, stop work and have the supervisor fill out an AVO and then take that AVO to Safety. If Safety finds an issue, they will communicate with the supervisor. Other than that, you need to follow any direction given by a supervisor and then grieve it afterwards if need be. **DOCUMENT!** Immediately document what was said and what happened and keep it in your records for the grieving process. Talk to your stewards as well.

Unfortunately, the REM truck driver is retiring and not being replaced. This means there will no longer be a

REM boot truck outside of the gate. If you wish to buy boots from them you will need to go to the actual store located at 789 Long Hill Rd, Groton, CT 06340.

Also please keep this in mind... everything you do on social media can and will be checked by your employer. They take hate speech and threats very seriously, as well as damaging remarks about the company.

New Members: Between days 0-30 days after your date of hire you must log onto the General Dynamics Service Center website at www.gdbenefits.com to enroll yourself, and your dependents, in the benefits package.

As always, do not forget to use the safety boot and eyeglass program that was negotiated by the MTC. A list of the different shoe manufacturers and times that they will be outside the front gate is available. The eyeglass store is open on both the inside of the main gate and the outside entrance for your convenience, check bulletin boards for the times they are open.

IMPORTANT:

If you are put on notice, going to be disciplined, or sent to Security to give a statement of any kind, you have the right to have a steward present. Your first words should be, "I want to talk to a Steward".

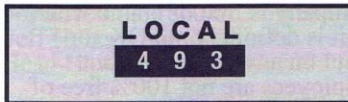

Union Meeting:

As you know our membership meetings have been postponed due to the social distancing regulations imposed by the State and Federal regulations. In addition to this the Executive Board met and approved a motion to suspend the July & August membership meetings for Vacation Purposes, but mostly for social distancing purposes. I have received permission from VP Monahan of the International 2nd District to suspend these meeting. During this period, the Executive Board will continue to meet and take any action that the Local Union can and should take in accordance with Article VI, Section 5 of our by-laws. The membership will be properly notified of this change.

We are hoping the next scheduled meeting is 2:45PM on Tuesday, September 2020 at the IAM Lodge 1871 Hall located at 18 Pleasant Street. You will be notified. All members are welcome and encouraged to attend to discuss any issues or concerns they may have. Note that 2nd shift members who would like to attend do not have to use their own time; an appropriate union business shop order is provided.

Thoughts:

I would like to thank all of you for adhering to the Company's and the Communities social distancing guidelines. It seems to be working here in the shipyard thankfully. Connecticut is one of the few states that have reduced the COVID-19 threat. This couldn't have happen without all of your participation. Wearing face covering is a hassle but it needs to be done when it is possible. Thank you to all.

I would like to welcome our new members who have been recently been hired. Many of them are unfamiliar with this kind of work environment and will need our help to adjust. I would hope all will be willing to provide this service.

Safety:

It should be noted that I have made a commitment to the Company that Local 261 will work with them on promoting a safe environment here in the shipyard. One of our initiatives is to promote a culture that has everyone thinking about safety no matter where we are. Naturally performing our scheduled work comes with

hazards where we have to be diligent every second that we are performing these tasks.

The Company helps by engineering the hazards out or providing PPE. Our experienced workers help by teaching and demonstrating safe work practices. We have been successful in this area. Our injury rates have steadily been reduced. Other parts of the job, like travel to and from the job site has been identified as an area of concern. Many of these injuries are from members with less than 5 years. I have participated in a "round table" discussion trying to determine how we can get this message to our new members as well as some of our senior members who sometimes become complacent with the job. I am curious on how messages are received by the younger generations. I am sure educators have changed their training process from the "Baby Boomers" to the "Generation X"s. I think we should take a look at this. It could help all of us to communicate better. **Something that needs to be said again.**

While the OSHA General Duty Clause requires that employers furnish it's employees a workplace free of hazards that are likely to lead to serious physical injury or death, we also have just as much responsibility to ourselves and our fellow workers to be accountable for workplace safety. That is not to say that the company is free of blame when an injury occurs and it is definitely not OK for them to ever take it out on any employee, but often times we as employees are not 100% free of blame either. We are given many of the tools and means to maintain our safety while on the job and it is up to us to use them effectively to maintain personal accountability for ourselves and to ensure we leave the yard the same way we entered it.

The company is again stating that if you do not feel your job site is safe, then you are to stop and report it to your supervisor. If your supervisor still tells you to work in what you feel is a genuinely unsafe area, find a union steward and get the safety department involved and they will make a determination. There is a list of union stewards below, and you can contact safety using the number on the back of your badge.

Work:

It has been reported that the next couple of months will be busy with overtime requests. After that, because of delays in material and other schedules the work slows down for quite a while. At this time they are looking at supplementing this with "road job" work rather than a reduction of the work force. A lot of times the Navy will provide repair work to fill in the voids.

Apprenticeship:

We are hoping to be opening the academic programs soon.

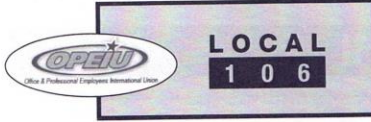

IMPORTANT: It is advised that you notify me one week in advance or as soon as you know when you will be returning to work from any Medical, Compensation or unpaid leave. The company doesn't know if you kept your dues paid up while you were out. It is important that I know your return date so I can submit a letter to the company to have your dues zeroed out under non collected. Once the company takes out your dues it will take me at least a month to return your money.

If **YOU** are sent to **SECURITY** for any reason or are being questioned by **MANAGEMENT**, **YOU** should request a **STEWARDS**. **YOU** do not have to answer any questions until you have **UNION REPRESENTATION**.

NEW HIRES

YOU must stay on top of your insurance coverage. There are many choices for you to review and time limits for you to apply for these benefits. You are now eligible to join the insurance **between days 0-30 of your date of hire**. This is the only 30 days to execute access to the health plan. If you do nothing you will automatically get medical but will not receive dental, extra eye care, and additional life insurance. If you are married or married with children, they will not be covered. You must log onto the General Dynamics Service Center website www.gdbenefits.com to enroll yourself and your dependents. It is **important** to enroll as soon as possible. **Do not be late.**

WITHDRAWAL CARD

If you stop working at Electric Boat you should make sure you request and receive a Withdrawal Card from the Union. 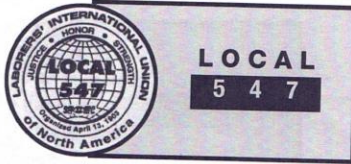

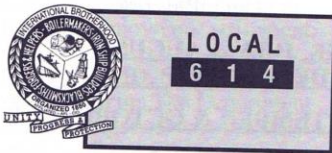
