#### This past year we have been faced with many challenges that we took head on. Overcame many obstacles. Corrected injustices from a bygone era. And, continued to promote our safety and wellness programs. It has not all been rainbows, bubble gum, and unicorns, but we made progress.

We came into the year amidst a Global Pandemic where we would have to deal with vaccinations, mask, and mandates or potentially become unemployed. The deadlines for the mandates and OSHA regulations have been extended, bastardized, and held up in the courts. There is nothing to celebrate. The OSHA standard gave an alternative to mandatory vaccinations, provided protection for workers, and gave relief to persons who became sick from the vaccine or infected at work.

Our Safety Committee has attended trainings to keep them aware of trends, and ahead of things contemplated while promoting our safety initiatives and new programs.

Historically, members who had their clearances suspended or revoked were terminated. In June of 2019 we corrected that injustice in part by executing a Memo that clarified the policy and those members became laid off. In November we capitalized on that memo, the need to grow the workforce, the amount if work available, and cooperation from the Company to provide work (with conditions) for those members.

The Metal Trades Council and affiliated Local Unions though not always in agreement with each other have stood shoulder to shoulder throughout this year and that is how we will march into the New Year. We will continue to take the issues head on to be more proactive than reactive. We will celebrate our victories and mourn our losses all for the betterment of our members.

With that, Merry Christmas. Happy Holidays. And a Safe, Healthy, Prosperous New Year.

#### INSURANCE OPEN ENROLMENT

It's almost that time of year again. Be ready to select the coverage that is best suited for your needs.

#### UNION REMINDERS:

**NEW HIRES YOU** must stay on top of your insurance coverage. There are many choices for you to review and time limits for you to apply for these benefits. You are now eligible to join the insurance between days 0-30 of your date of hire. This is the only 30 days to execute access to the health plan. If you do nothing you will automatically get medical but will not receive dental, extra eye care, and additional life insurance. If you are married or married with children, they will not be covered. It is important to enroll as soon as possible. Do not be late. I suggest that you call to make arrangements for health insurance since all calls are recorded. In the past, there were problems with online enrollments. There are many options to choose or reject. Contact General Dynamics Service Center (1-888 432-3633)

New Members: Between days 0-30 days after your date of hire you must log onto the General Dynamics Service Center website at www.gdbenefits.com to enroll yourself, and your dependents, in the benefits package.

As always, do not forget to use the safety boot and eyeglass program that was negotiated by the MTC. A list of the different shoe manufacturers and times that they will be outside the front gate is available. The eyeglass store is open on both the inside of the main gate and the outside entrance for your convenience, check bulletin boards for the times they are open. **IMPORTANT:** Members who are out of work on any leave of absence such as Workers Compensation, Sedgwick short term disability insurance, FMLA, etc. it is your responsibility to pay your portion for medical, dental, and vision. You can be dropped from your benefits if you don't keep up your payments. Please don't forget to notify the Union Hall (860-442-8281) if you change your address, phone number, or name. We need to have the correct information! When you notify the company of these changes they do not give the Union this new information. We appreciate your cooperation in this matter.

**REMINDER:** If you are out of work on compensation or accident & sickness insurance or any unpaid leave it is your responsibility to pay your dues. If your dues fall behind more than three months, your membership could be suspended. If you are out of work and have any questions regarding your dues, please call the Union Hall at 860-442-8281.

**IMPORTANT:** It is advised that you notify me one week in advance or as soon as you know when you will be returning to work from any Medical, Compensation or unpaid leave. The company doesn't know if you kept your dues paid up while you were out. It is important that I know your return date so I can submit a letter to the company to have your dues zeroed out under non collected. Once the company takes out your dues it will take me at least a month to return your money.

At our last membership meeting a motion was passed to supplement the expense to provide a Christmas Holiday Party for our members. By now you may have heard that the Federal Mandate for vaccinations has been extended until January 8, 2022. Not to be confused with the Emergency OSHA Standard that has a deadline of January 4, 2022 which has been delayed because of legal suits on some of their language. Confused??? So am I. But! We expect that the vaccination mandate will happen and it will or could impact our well being. The Company explained that the reason for their hesitancy to comply with the mandate was because they were trying to clarify or interpret the language with the government on which contracts required compliance;" Supply or Service "? Confused even more??. ME TOO! But the bottom line is, with the Government Mandate you will be required to get vaccinated, the OSHA Mandate (once it gets out of court) will allow you to work without vaccinations but you will be required to be tested weekly ( at your own expense) and follow social distancing guidelines. Fines and penalties will be levied and enforced.

The Company has decided that the best thing for everyone is we all should be vaccinated; at last something that I can agree with. As you know they have decided to incentivise their employees with a \$500 bonus to all that have been or will be vaccinated before January 4th 2022. There is more to follow on this incentive but we did get a commitment that if you cannot meet the deadline for the vaccination because of the medical timeline from being positive with the virus you will be granted a "temporary medical exemption" as long as you commit to the vaccination. Another issue is that the OSHA Mandate expects employers to know where they stand with the % of employees who have been vaccinated by December 6th. They stated that this is an occupational health requirement that will not violate any HIPAA regulations. There is more to come on this. I believe that vaccinations are the right thing to do, mandate or not. Please note: Hopefully all have made the proper selections for open enrollment including designating their deductions to the HSA account. Also anyone that may need to apply for the new CT Family Paid Leave should contact a Steward for information. If they do not have the answer they can contact me.

On behalf of our Officers and Stewards we wish all you and your family a Merry Christmas and Great New Year. It is important that we work together and we work safely! If we do, we can get through this.

Dear Brothers and Sisters:

Open enrollment is upon us. November 17th to December 3rd. It is very important to choose the plan that will work for you and your family. With the Enhanced plan the Union negotiated

the company and the company agreed to install \$500 single/\$1000 family into your Health Savings Account and they agreed to match for every dollar up to \$300 single/\$600 family into your HSA as well. This is negotiated for the remainder of our current contract. The money in the HSA is your money even if you leave the company. Talk to a steward if you have any questions. If you have been vaccinated take a photo of your card and send it to the EB website:

proofofvaccination@gdeb.com with your name and badge# in the subject line. There is a \$500 incentive to get the vaccine. The Union requested a lot more. We were ESSENTIAL WORKERS, working every day without a vaccine on odd shifts to get the job done. Our Union leadership felt we should have received hazard pay and bonuses. It shows me that the company doesn't really care, as long as the job gets done.

We will be receiving a raise on December 19th. The next scheduled raise after this one is not until January 22nd 2023. With the 13 months in between raises, we will not be receiving a raise in 2022. Our current contract expires on September 29th 2023. It may be our best chance in many years to get a decent package. The Columbia class construction is the nation's 1 priority for our national security. We have to get better than 3% raises. We must push for COST OF LIVING adjustments to offset these peaks of inflation we are experiencing now. We have proven ourselves to be an ESSENTIAL WORKFORCE and we must demand to be fairly compensated for it. Safety shoes. The stewards have the list of our members and their safety shoe status. If you have \$200 on your account please go get your shoes before the end of the year. Sincerely;
